<i>A compilation of programs and specific actions to be completed in a stated sequence, including proposed changes to any applicable zoning ordinances, official maps, sign regulations, erosion and storm water control ordinances, historic preservation ordinances, site plan regulations, design review ordinances, building codes, mechanical codes, property maintenance and housing codes, sanitary codes or subdivision ordinances, to implement the objectives, policies, plans and programs contained in the other elements.</i>	
<b>Chapter 4: Issues and Opportunities</b> .....	4-1
<i>Provides information regarding the socioeconomic conditions and growth patterns in the Village of Hortonville. Background information includes population trends, household structure and trends, and education and income levels.</i>	
<b>Chapter 5: Land Use</b> .....	5-1
<i>Provides an assessment of the amount, type, intensity and net density of existing land uses such as agricultural, residential, industrial and other public and private uses; an analyzes of the trends in supply, demand and the price of land, opportunities for redevelopment and existing and potential land-use conflicts.</i>	
<b>Chapter 6: Economic Development</b> .....	6-1
<i>Provides an inventory of the labor force characteristics, commuting patterns, location of workplace, economic base information to promote the stabilization, retention or expansion of the economic base and quality employment opportunities in the Village of Hortonville.</i>	
<b>Chapter 7: Housing</b> .....	7-1
<i>Provides an assessment of the age, structural, value and occupancy characteristics of existing housing stock in the Village of Hortonville.</i>	
<b>Chapter 8: Transportation</b> .....	8-1
<i>Provides an assessment of existing transportation facilities including highways, transit, systems for persons with disabilities, bicycles, walking, railroads, air transportation, trucking and water transportation.</i>	
<b>Chapter 9: Utilities and Community Facilities</b> .....	9-1
<i>Provides a compilation of background information to guide the future development of utilities and community facilities such as sanitary sewer, storm water management, water supply, solid waste disposal, on-site wastewater treatment</i>
